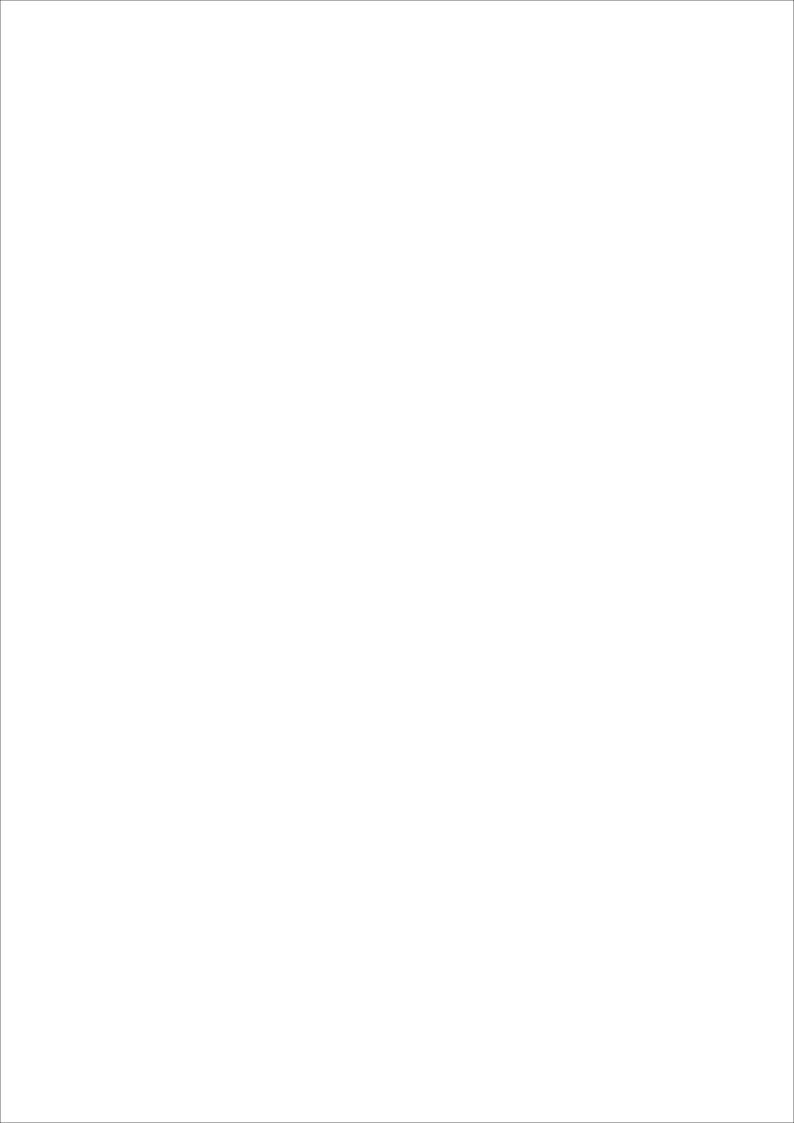

- 1 The statement pursuant to Section 102(1) of the Companies Act, 2013 in respect of the Special Business under item No. 9 of the Notice is annexed.
- 2 A member entitled to attend and vote at the Annual General Meeting (the "Meeting") is entitled to appoint a proxy to attend and vote on a poll instead of himself and the proxy need to be a member of the Association.

Pursuant to the provisions of Section 105 of the Companies Act 2013, a proxy shall not be entitled to vote excepting through a ballot paper. Further a proxy shall not have any right to speak at the meeting.

A Member can act as a proxy on behalf of members not exceeding fifty.

- 3 The instrument appointing proxy in order to be valid should be deposited at the Registered Office of the Association, not less than 48 hours before the commencement of the Meeting. Organizational members are requested to send to the Association, a duly certified copy of the nomination of a member authorizing him/her to attend and vote at the Annual General Meeting
- 4 **Book Closure**: The Register of Members will remain closed from August 20, 2022 to August 27, 2022 (both days inclusive).
- 5 Members/Proxies should bring in their Attendance slip sent herewith duly filled in for attending the Meeting. ONLY MEMBERS/PROXIES WILL BE ADMITTED INTO THE AUDITORIUM FOR THE MEETING.
- 6 The Register of Executive Committee Members maintained under Section 170 of the Companies Act, 2013 will be available for inspection by the Members at the Annual General Meeting.
- 7 Brief resume of the Executive Committee Members seeking re-election is provided as annexure to this Notice.
- 8 Notice of AGM along with the Annual Report, Proxy form and Attendance Slip is being sent to all the Members of the Association to their mailing address registered with the Association. Notice of AGM is also being sent by electronic mode to members whose e-mail IDs are registered with the Association. The Annual Report of the Association for 2021-22 shall also be available in the Association's website www.sihra.in
- 9 Members are requested to bring their copy of the Annual Report for the meeting. As a measure of economy and a step toward green initiative, copies of the Annual Report will not be distributed at the venue of the Annual General Meeting.

Updation of Members details:

10 The format of the Register of Members as prescribed by the Ministry of Corporate Affairs under the Act, to record additional details of Members, including ownership of the Hotel/Restaurants, the details of the PAN, email address, persons authorized on behalf of the owner establishment including the CIN No., Registration No., GSTIN, Legal Name, Trade Name, persons responsible for the respective hotels/restaurants etc. has been implemented and is being maintained by the Association.

11 Voting through electronic means

In compliance with the provisions of Section 108 of the Companies Act, 2013 and Rule 20 of the Companies (Management and Administration) Rules 2014 as amended from time to time, the Association is pleased to provide its Members the facility of remote e-voting to exercise their right to vote on the resolutions proposed to be passed at the 71st Annual General Meeting by electronic means. The Members can cast their votes electronically from a place other than the venue of the AGM through e-voting services provided by CDSL platform on all resolutions set forth in this Notice.

- 12 The remote e-voting period will commence at 9.00 a.m. on August 24, 2022 (3 days prior to the date of AGM) and will end at 5.00 p.m. on August 26, 2022 (the day prior to the date of AGM). The e-voting module shall be disabled by CDSL for voting thereafter. During this period Members of the Association whose names appear in the Register of Members as on August 19, 2022, the cut-off date i.e. the date prior to the date of commencement of book closure may cast their vote electronically on the resolutions set forth in the Notice.
- 14 In addition, the facility for voting through ballot paper shall be made available at the venue of the AGM and the Members attending the AGM and who have not cast their vote by remote e-voting shall be eligible to cast their vote at the AGM venue.
- 15 The Association has appointed KSM Associates, Company Secretaries, Chennai and Mr. S Subbaraman, Advocate, Chennai as the scrutinizers to scrutinize the remote e-voting and physical voting at the venue of the AGM in a fair and transparent manner. The Members desiring to vote through remote e-voting are requested to refer to the detailed e-voting procedure given hereunder.

Procedure for "Remote E-voting" is detailed hereunder:

Initial password is provided at the bottom of the Attendance slip for the Annual General Meeting

EVEN (E Voting Event Number) User ID PASSWORD/PIN

e-Voting Procedure using the CDSL platform

- i) Log on to the e-voting website www.evotingindia.com
- · Click on "Member" tab
- ii) Now enter your user ID as provided in the Attendance slip/top of the email communication sent by CDSL and then enter the image verification as displayed and click on "Login".
- iii) Enter password given in the email communication from CDSL/attendance slip sent by the Association
- iv) After entering these details appropriately, click on "SUBMIT" tab.
- ·Members will then reach directly the Company selection screen.
- v) Click on the EVSN for SOUTH INDIA HOTELS AND RESTAURANTS ASSOCIATION on which you choose to vote.
- vi) On the voting page, you will see "Resolution Description" and against the same option "YES/NO" for voting. Select the option YES or NO as desired. The option YES implies that you assent to the Resolution and option NO implies that you dissent to the Resolution.
- vii) Click on the "RESOLUTIONS FILE LINK" if you wish to view the entire Resolution details.
- viii) After selecting the Resolution you have decided to vote on, click on 'SUBMIT". A confirmation box will be displayed. If you wish to confirm your vote, click on "OK", else to change your vote, click on "CANCEL" and accordingly modify your vote.
- ix) Once you confirm your vote on the Resolution, you will not be allowed to modify your vote.
- x) You can also take a print out of the voting done by you by clicking on "Click here to Print" option on the Voting page.
- xi) Non-individual owners, who are partnership firms or body (ies) corporate and not individuals, who are the owners of the hotels/restaurants registered as Members of the Association are required to log on to https://www.evotingindia.com and register themselves as Corporates.
- xii)They are required to submit a scanned copy of the Registration form bearing the stamp of the entity to helpdesk.evoting@cdslindia.com.
- xiii)After receiving the login details they have to create a compliance user using the admin login and password. The compliance user would be able to link the account(s) which they wish to vote on.
- xiv)They should send scanned copy (PDF/JPG format) of the relevant Board Resolution/Authority letter etc. which they have issued in favour of the authorized signatory (ies) together with attested specimen signature of the duly authorized signatory (ies) who are authorized to vote, to the scrutinizer through e-mail with a copy marked to helpdesk.evoting@cdslindia.com
- xv)The list of accounts should be mailed to helpdesk.evoting@cdslindia.com and on approval of the accounts they would be able to cast their vote.

Other instructions:

- i) Members who are already registered with NSDL, for e-voting can use the existing user ID and password/PIN for casting their votes.
- ii) Members are requested to update their mobile numbers and e-mail id in the user profile details of the Membership no. which may be used for sending future communication(s).
- iii) The voting rights of Members shall be in proportion to the number of votes they are eligible for on the cut-off date, i.e The number of votes a member is eligible for is calculated on the basis of 1 (ONE) vote for every Rs. 100/paid as subscription fees for the year.
- iv) The Members who have cast their votes by remote e-voting prior to the AGM may also attend the AGM but shall not be entitled to cast their votes again.

- v) The Member can opt for only one mode of voting i.e. either through remote e-voting or by ballot at the venue of the AGM. If a member casts vote by both modes, then voting done through remote e-voting shall prevail and ballot shall be treated as invalid.
- vi) The Chairman shall at the AGM, at the end of discussion on the resolutions on which voting is to be held, allow voting with the assistance of scrutinisers by use of ballot paper for all those members who are present at the AGM but have not cast their votes by availing the remote e-voting facility.
- vii) The scrutinizer shall by the end of conclusion of the voting at the AGM venue will first count the votes cast at the meeting and thereafter unblock the votes cast through remote e-voting in the presence of at least two (2) witnesses not in the employment of the Association and shall make not later than 3 days of the conclusion of the AGM, a consolidated Scrutinizer's report of the total votes cast in favour or against, if any, to the President or a person authorized by him in writing, who shall counter sign the same and declare the result of the voting forthwith.
- viii) The results declared along with the report of the scrutinizer shall be placed on the website of the Association and on the website of CDSL immediately after the declaration of the result by the President or a person authorized by him in writing.

EXECUTIVE COMMITTEE'S REPORT

To the Members of The South India Hotels and Restaurants Association

Executive Committee Members of The South India Hotels and Restaurants Association (SIHRA) have great pleasure in presenting the 71st Annual Report of the Association together with the Audited Financial Statements for the financial year ended March 31, 2022.

The financial year ended March 31, 2022 marked the second year since the World Health Organisation declared the outbreak of COVID-19 as a pandemic. During the year under review, countries across the globe continued to face economic and social disruptions along with the loss of lives and livelihoods. Eruptions of new waves and variants of the virus necessitated localised restrictions and lockdown. In April 2021, India witnessed a second wave of infections followed by another wave of infections in the fourth quarter of F.Y. 2021-22.

Financial Results

Operating Results:

The Association has earned an income of Rs. 70.48 lakhs for the year ended March 31, 2022 which was Rs. 11.56 lakhs less than that of the previous year i.e. 14% less than that of the previous year. The depreciation for the year was Rs. 11.88 lakhs as compared to Rs. 13.06 lakhs for the previous year. The income over expenditure for the year amounts to Rs. 2.07 lakhs as compared to the excess expenditure over income of Rs. 19.40 lakhs for the previous year. Reserves and surplus as on March 31, 2022 stood at Rs. 592.16 lakhs as compared to Rs. 582.47 lakhs for the previous year. The financial results once again bear the testimony to the faith and support extended by the Members over the years and the sincere efforts of the Members of the Executive Committee, in spite of the covid – 19 pandemic situation. The Executive Committee is confident that the Members would continue to extend their support to the functioning of the Association and also pay the Annual subscription dues on time which has been reduced by 25% as compared to the annual subscription for the year 2020-21.

The Income and Expenditure statement for the year ended March 31, 2022 and the Balance Sheet as at March 31, 2022 are enclosed for the information and perusal of the Members.

Borrowings:

The Association has not borrowed any amounts from any financial institutions or banks during the year under review and has no borrowings.

Capital Expenditure:

During the financial year 2021-22, your Company has incurred a capital expenditure of Rs. 0.49 lakhs towards purchase of laptop computer for the Association.

Fixed Deposits

The Association does not accept fixed deposits hence there are no dues on account of principal or interest on fixed deposits.

Recognition and awards

Mr. K Syama Raju honoured with Kannada Rajyotsava award by the Government of Karnataka

Government of Karnataka has honoured Mr. K Syama Raju with the Kannada Rajyotsava Award in recognition of his Entrepreneurship. The Rajyotsava Awards are presented by the Government of Karnataka based on public nominations to laud unsung heroes who have made significant contributions to the citizens of Karnataka in the fields of arts, literature, culture, education, industry, sports, medicine, science, social service, and public affairs.

SIHRA as Training Partner of Tamil Nadu Skill Development Corporation

Tamil Nadu Skill Development Corporation (TNSDC), the nodal agency for skill development related activities in the State of Tamil Nadu has appointed your Association as a training partner in green channel.

SIHRA as a partner of TNSDC could provide training to unemployed youth in hospitality services and generate required manpower to address the manpower shortage in hotel industry. On completion of the training, successful candidates will be registered in the TN Skill Registry which will be the state repository of skilled candidates and accessible to the private employers who have registered in the Tamil Nadu Private Job Portal. This will ensure that the trainees who have undergone short term skill training get immediate employment.

As a training partner, SIHRA would set up class room facility, identify faculties/volunteers from the industry for imparting training and youth interested in getting trained. On completion of training, the trained youth could get employed by hotels. SIHRA would seek the support of the Tourism department, district Collectors and other district level authorities to identify youth interested in getting trained with employable skills. Members of the Association interested in being part of the skill development initiative of SIHRA, could approach the Association for further details.

Activities of SIHRA including Meetings and memorandums submitted to Government officials

- President, Mr. K. Syama Raju met Shri G. Kishan Reddy, Minister of Tourism and Culture, Government of India, at the meeting convened by the Ministry of Tourism at Bangalore where tourism ministers of all the Southern States were present, and presented a memorandum emphasising the need for issuing clarification by the Ministry of Tourism on licence fee demands by PPL, Novax to protect hoteliers' interests, simplification classification norms, reduction of GST to 5 per cent for the next two years, industry status to hotel sector to avail subsidies given to manufacturing industry etc.
- 2. President, Mr. K Syama Raju and the Executive Committee members met the Karnataka Chief Minister and urged that the Chief Minister to propose to the GST Council to maintain the GST rate on restaurants at 5% and to raise the room tariff slab to which 12% GST rate is applicable from Rs. 7,500/- to Rs. 9,000/-. President requested the Karnataka Government to organize state level food festival which would boost tourism in the state. Other State Governments in Southern India also were requested to propose to the GST Council on similar lines.
- 3. SIHRA continues to boost hospitality sector by engaging in dialogue with various governments about the challenges faced by the hoteliers, among other efforts.
 - President, K Syama Raju who was instrumental in getting "industry status" to star hotels in Karnataka, had been following up with the Karnataka Government to extend the concessions to unclassified hotels also, and the Government had reacted positively stating that the benefits would be extended to all the hotels which are registered under the Karnataka Tourism Trade (Felicitation and Regulation) Act, 2015, which facilitates, regulates and promotes tourism trade in the State of Karnataka. On the advice of the President, SIHRA has coordinated with the hoteliers in Karnataka to register themselves under the KTTF Act, to enable them to avail the benefits extended to classified hotels in Karnataka.
- 4. Your Association has assisted the State Governments by requesting the hotel members of the Association to accommodate doctors and nurses, asymptomatic and symptomatic COVID patients at hotels since the beginning of the pandemic.

- 5. Your Association's continuous follow up with the Government of Tamil Nadu and other senior officials for release of payments due to hoteliers had resulted in the Government ordering release of payments from various government expenditure accounts, to the hoteliers for providing food and accommodation to physicians, nurses, and other health workers, who worked in covid-19 isolation wards in Government institutions under the control of Directorate of Medical and Rural Health Services. Payments due to Hoteliers up to September 2021 has been released and the balance dues for the period October 2021 to December 2021 is expected to be released in the next two months
- 6. Your Association's request to various State Governments to consider vaccinating hotel staff irrespective of their age, and considering them as frontline workers has been accepted and the Southern State governments had issued orders to vaccinate hotel staff considering them as frontline workers. Your Association coordinated with the local authorities and governments and organized camps in various cities for vaccinating hotel staff irrespective of their age.
- 7. Consistent follow up by your Association with Tamil Nadu Government through Commissioner, Excise and Prohibition, has resulted in removal of restrictions on bar timings.
- 8. Your Association has been requesting the Tamil Nadu Government to permit people participation in weddings, refund of FL3 license fee for the entire lockdown period and for taking back the expired beer stock.
- 9. Nilgiris District Administration had ordered closing down the operations of all the hotels in Nilgiris District since they found a few positive cases when RTPCR test was conducted. Due to the timely intervention of SIHRA by escalating the issue to the senior officials of the Government, the District Administration of Nilgiris permitted opening of all the Hotels, on the very next day.

Nomination to Government Committees, participation in government organized tourism meetings

- Department of Tourism, Government of Tamil Nadu has formulated guidelines for adventure tourism in order to promote safe conduct of adventure tourism in the State and organised a meeting of all the stakeholders for a consultation meeting to discuss the draft guidelines for adventure tourism activities which was earlier circulated to adventure tourism stakeholders seeking their comments and suggestions.
- · Representing SIHRA, Mr. Sundar, Director Operations,
- i) attended the meeting convened by Parliamentary Standing Committee on Tourism and Culture, Government of India, for a discussion on developing Beach Tourism in Tamil Nadu. At the said meeting, policy guidelines from Government of India for developing Ariaman Beach near Rameswaram as a beach destination and to upgrade Chennai Port to bring back the glory of Cruise Liners to Chennai were discussed.
- ii) participated as a guest speaker in the CII organised conference on virtual platform on the theme "Tourism Development in deep down Southern Districts Thoothukudi, Tenkasi and Kanyakumari" for promoting travel and tourism in the deep-down southern districts.
- iii) attended the Pre-Budget meeting of Tamil Nadu Government and requested the government to consider extending the benefit of low cost power, property tax etc. enjoyed by manufacturing industries, to the struggling hospitality sector in order to avoid closure/sale of hotels due to pressure from financial institutions.
- iv) Submitted a memorandum to the Government to consider waiver of property tax for 6 months and demand charges by Electricity Board, permit hotels to pay only the actual power consumption charges for the lock down period etc. as has been extended by the Government of Karnataka. SIHRA's request for higher allocation in the budget for tourism has been considered by the Tamil Nadu Government and an amount of Rs. 246.06 crore has been allocated for tourism.
- v) participated as a resource person in the webinar on "Impact of the pandemic on Tourism Business", organized by the Department of Catering Science and Hotel Management and B.Voc Hospitality Management, Coimbatore in association with PSG CAS Institutional Innovation Council
- vi) participated in the Tourism stakeholders meeting in Chennai organized by the Southern Regional Office, Ministry of Tourism, Government of India to informally discuss the actions and activities to be carried out for development of tourism in Tamil Nadu.
- President and EC Members attended a function hosted by the Pondicherry Hoteliers Association wherein the participants had discussions on the measures that could help the tourism sector to recover.
- World Tourism Day was celebrated in Madurai and Coimbatore, wherein a series of events were held throughout the city such as blood donation camp, planting of sapling, community service etc. District Collectors of the respective cities participated and addressed the stakeholders and promised to initiate steps to revive tourism in their regions. Mr. D Srinivasan, Treasurer of your Association participated in the celebrations held in Coimbatore.
- SIHRA hosted an inter-active session with Nilgiris District Collector and Director of Tourism. According to the Director of Tourism, the Tamil Nadu Government is considering giving hospitality sector industry status, with incentives at par with the hotels in Karnataka.

In the inter-active sessions organized by SIHRA at Courtyard by Marriot, Madurai and at Ramyas Hotel, Trichy
along with TTF, with the hoteliers of the respective cities, participant hoteliers discussed strategies for
improving revenue post Covid collectively, assured support to protect each other's interest and to promote their
respective cities as a destination along with Tamil Nadu Government.

Orders passed by Hon'ble High Court of Madras

- 1. Hon'ble High Court of Madras has ordered that Police Department has no powers to regulate the restaurant timings or to close the restaurants.
- 2. Hon'ble High Court of Madras has ordered closure of all the bars at The Tamil Nadu State Marketing Corporation (TASMAC) Shops. TASMAC is vested with the exclusive privilege of wholesale supply of IMFL for the whole State of Tamil Nadu
- 3. Madras High Court sheds clarity on Section 33 of the Copyright Act, 1957 in M/s Novex Communications Pvt. Ltd. vs DXC Technology Pvt. Ltd.
 - The Hon'ble High Court of Madras on December 8, 2021 had passed an order in the M/s Novex Communications Pvt. Ltd. vs DXC Technology Pvt. Ltd giving clarity on Section 33 of the Copyright Act 1957.
 - Novex Communications Pvt. Ltd. (Novex) had filed two suits before the Hon'ble High Court of Madras, a company engaged in the business of distribution of content, primarily film songs against DXC Technology Pvt. Ltd. ("DCX"), praying for issuing
- a) a judgement and decree of Mandatory Injunction restraining Defendant from publically performing or in any manner communicating the sound recordings of the songs assigned and authorized to the Novex and
- b) a judgment and decree directing the Defendant, DXC Technology Pvt. Ltd. to pay Novex, initial Damages of a sum of Rs.51,60,000/- (Rupees Fifty-One Lakhs and Sixty Thousand Only) for illegal exploitation of the sound recordings of the songs assigned and licensed to the Novex.
 - The main issue decided by the Hon'ble Court was that Novax does not fall within the definition of copy right society as contemplated under Section 33 of the Copyright Act, 1957 and hence statutorily barred from issuing licenses. In view of this, there is no question of the defendant being liable for failing to take license from Novex which has no authority to issue the same. Considering the facts and circumstances of the case, the Hon'ble Court passed an order directing the plaintiff, Novex in each suit to pay costs of Rs. 1,00,000/- to the defendant, DXC Technology Pvt. Ltd.

4. Property tax increase

Chennai Corporation had unilaterally increased the property tax by 200% to 500%. Writ petitions were filed by many property owners challenging the enhancement of property tax. Hon'ble High Court had passed orders quashing the unilateral decision of Chennai Corporation increasing the property tax by 200 to 500%.

Government order revising the property tax

The Tamil Nadu government has revised the property tax on all residential properties by 25 per cent to 100 per cent, industrial and private school and college properties by 175 per cent, and commercial properties by 250 per cent. The tax on vacant land has been increased by 100 per cent in all urban local governments. Hotel properties in Chennai City will be taxed on par with commercial properties which were earlier classified under special category and taxed accordingly along with cinema theatre, hospital, kalyana mandapam, is now treated as nonresidential commercial properties and taxed on par with commercial properties. The revised rates come into effect on 1 April 2022.

Relaxation of Covid-19 restrictions:

Tamil Nadu Government has lifted the ban and removed the restrictions on social, cultural, religious and political gatherings with effect from March 3, 2022. The Government of Tamil Nadu has also permitted that weddings and other related functions can be held with the participation of up to 500 people and up to 250 people are allowed to participate in deaths and funerals. However, people are advised to continue to follow Covid preventive measures such as wearing masks and maintaining social distancing, and getting vaccinated.

Activities of and at SIHRA

"SIHRA Connect", an online platform, exclusively for the Members of the Association was launched and a detailed presentation was made to the Members. Through this online platform, knowledge sharing sessions and webinars would be conducted for the benefit of Members. Members also would be able to present their hotels online at a nominal cost, to the audience of travel agents and tour operators.

Activation of Social Media

Face book, LinkedIn and Twitter accounts of the Association have been activated.

All Government Orders (G O), circulars relating to the hospitality and tourism industry is being circulated to the Members through whatsapp immediately after the same are released by the Government.

Your Association is taking various steps and activities in order to increase the membership of the Association and meeting hoteliers in other cities as part of the membership drive.

Your Association is doing its best for hospitality growth in South India by holding its Executive Committee Meetings in smaller towns and neighboring areas, with good tourism potential. EC members interact with local bodies and associations for strengthening partnerships for better growth.

Legal Matters:

Status Report of the petition filed before the National Company Law Tribunal

Casino Hotels vs FHRAI & others and Hotel and Restaurants Association of Eastern India & others vs FHRAI and others

The Hon'ble Tribunal after hearing the counsels of the Petitioners and going by the nature of the dispute, made a suggestion that the parties should examine the possibility of resolution through mediation by invoking Section 89 of CPC. Both the Counsels stated that they would explore the possibility and take instruction and would inform the Hon'ble Tribunal at the next hearing date. On the next hearing date, both the parties mentioned that the mediation process had failed and that they want the matter to be argued on merits and the matter was listed for hearing on February 24, 2022, and at the request of both the parties for physical hearing, the matters were posted for physical hearing on 25th March 2022.

The Hotel and Restaurants Association of Eastern India & Others vs FHRAI & others:

The matter was listed on 20.05.2022 before Hon'ble NCLT, Principal Bench. Both sides argued the matter at length and concluded the arguments in the matter. The Ld. Tribunal was pleased to orally reserve the matter for judgement. However, the matter was listed again on 07.07.2022 before the Bench for further consideration.

Since both the parties had confirmed compliance of the directions, the Hon'ble Tribunal directed the matter to be listed on 28.07.2022. The Court orally mentioned that the matter would be posted for pronouncement of judgment.

Income tax - Appellate Tribunal, Chennai

Three appeals were filed by the Association against the orders dated 12.01.2018 of the learned Commissioner of Income-tax (Appeals). Issues and facts of the case of all appeals are similar.

The Association being a charitable institution registered under Section 12A(a) of the Income-tax Act, 1961 (the Act), carries out activities covered under the definition of "Charitable purpose" enumerated in Section 2(15) of the Act. The Association filed its return of income for the assessment years 2011-12, 2012-13 and 2014-15.

As per the Assessing Officer, the objects of the Association are not charitable in nature and that the membership to the Association is very limited and restricted to urban areas of South India. The Association has no control over its members and there is no benefit to the public at large and hence invoked Section 2(15) of the Act and denied benefit under section 11 of the Act to the Association.

On an appeal to the learned Commissioner (Appeals) against the order of the Assessing Officer, the CIT (Appeals) also confirmed the order of the Assessing Officer in denying the claim made under Section 11 of the Act as there is no benefit to the public at large and no charitable activity is carried on by the Association.

On an appeal to the learned Appellate Tribunal against the order of CIT (Appeals), the learned Appellate Tribunal stated that considering the proviso to section 2(15) of the Act, it is clear that any activity of rendering any service in relation to any trade, commerce for a cess or fee or any other consideration, irrespective of the nature of use or application or retention of the income from such activity is not charity and the Association was only doing services to its members in relation to hotel business, and hence the activities of the Association cannot be considered as charitable activity.

The learned Tribunal confirmed the order of the Assessing officer and the CIT (Appeals) based on the findings of the Assessing Officer that the Association was doing only consolidation of its manpower, potential and use for the benefit of the members of the Association and no benefit to the public at large. The appeals were dismissed by the learned Tribunal.

Your Association will be filing a petition before the Hon'ble High Court of Madras against the order of the Learned Tribunal dismissing the appeals of the Association and denying the claim made under Section 11 of the Act.

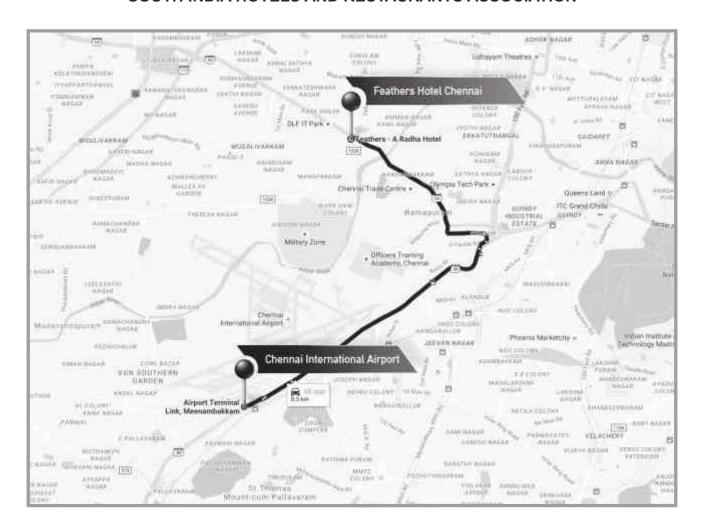

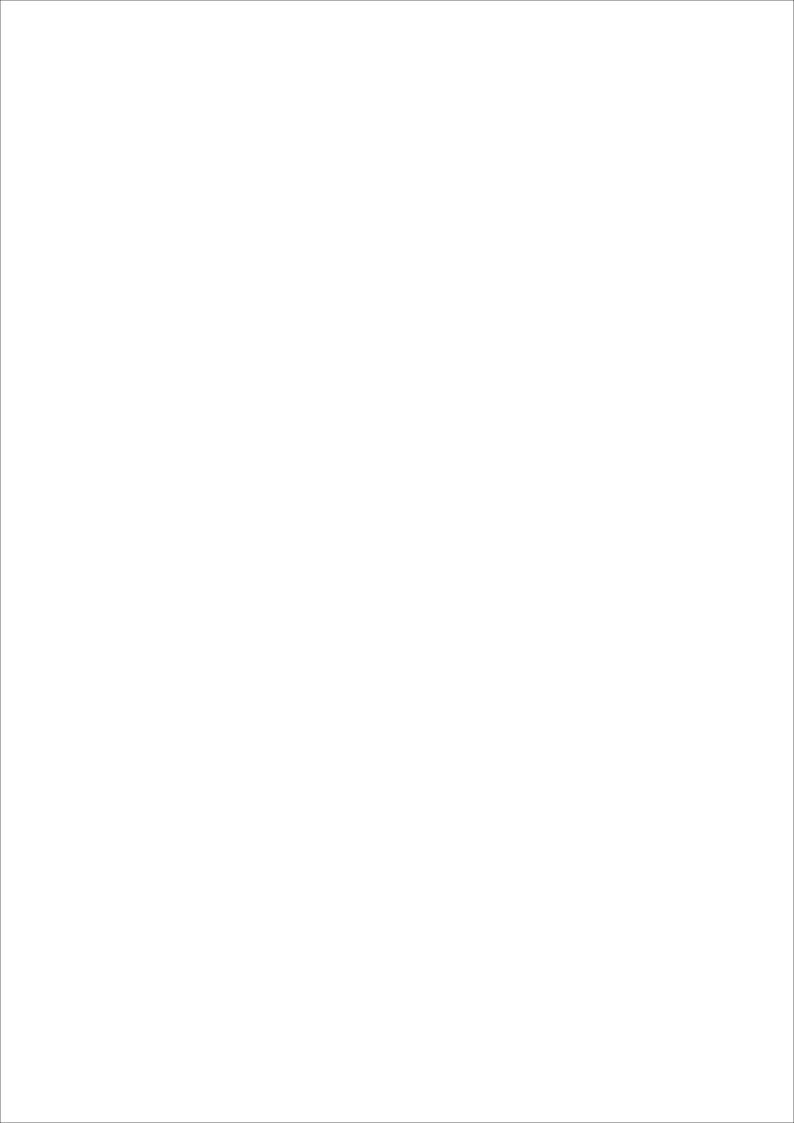
